TAKE NOTICE that sealed Bids for a proposed Contract for the project known as FURNISHING & INSTALLING PLANT MATERIAL AT VARIOUS PARKS (BID #0073-22) will be publicly received, opened and read aloud by the Purchasing Agent for the Monmouth County Board of Recreation Commissioners at the Monmouth County Park System Headquarters Building, Thompson Park, 805 Newman Springs Road, Lincroft, New Jersey on THURSDAY, JANUARY 5, 2023 at 10:00 AM prevailing time.

PRE-BID INSPECTION. A pre-bid meeting **is not** scheduled for this project. Bidders are expected to examine existing conditions at the project site that will bear on the proposed work.

BIDDING DOCUMENTS AVAILABLE. Bidders may obtain copies of the Bidding Documents on a Compact Disk (CD):

STATUTORY REQUIREMENTS. The successful Bidder will be required to comply with P.L. 1975 c.127 (N.J.A.C. 17:27) "Affirmative Action," (42 U.S.C.512101 et seq) "American with Disabilities Act," New Jersey State Business Registration (N.J.S.A. 52:32-44), and all other laws and regulations that apply to bidding and the performance of the proposed Contract.

FORM OF BID. Bids must be submitted on the proposal form provided or an exact duplicate in the manner designated and required by the specifications. Bid submitted must be enclosed in a sealed envelope bearing the name and address of the bidder, the title of the bid "**FURNISHING & INSTALLING PLANT MATERIAL AT VARIOUS PARKS (Bid #0073-22)**" and the words "Sealed Bid." FORMS TO ACCOMPANY BID. Each Bidder shall complete and submit with its Bid the following: Non-Collusion Affidavit (blank copy included in the Bidding Documents), New Jersey State Business Registration (N.J.S.A. 52:32-44). Bidders shall submit at least one (1) original of each form, with an original signature.

NOTICE TO BIDDERS (Continued)

RIGHTS TO REJECT BIDS. The Monmouth County Board of Recreation Commissioners shall have the right to reject any or all Bids; to reject a Bid not accompanied by any documents called for by the Bidding Documents; to reject a Bid which is in any way incomplete or irregular; and to waive any informalities contained in the Bids.

EQUAL OR TIED BIDS. The Monmouth County Board of Recreation Commissioners shall have the right to award the Contract to any one of the lowest responsible Bidders whose Bids are equal to or tied.
